## **NOTIFICATION NO. 1180**

It is hereby notified for the information of all concerned that the Board of Management at its 71st meeting held on 15/3/2023 approved the following guidelines for the students w ho are pursuing two academic programmes simultaneously with effect from the date of this meeting i.e. from 15th March, 2023:

- A student can pursue two full time academic programmes in physical mode provided that class timings for one programme do not overlap with the class timings of the other programme.
- A student can pursue two academic programmes, one in full time physical mode and another in Open and Distance Learning (ODL)/Online mode; or up to two ODL/Online programmes simultaneously.
- Degree or diploma programmes under ODL/Online mode shall be pursued with only such HEIs which are recognized by UGC/Statutory Council/Govt. of India for running such programmes.
- Degree or diploma programmes under these guidelines shall be governed by the Regulations notified by the UGC and also the respective statutory/professional councils, wherever applicable.
- <u>No retrospective benefit can be claimed</u> by the students who have already done two academic programmes simultaneously prior to the notification of these guidelines.
- The above guidelines shall be applicable only to the students pursuing academic programmes other than Ph.D. programme.
